SPEAKER BIOGRAPHY

Judge Michael Trickey (Ret.), JAMS – Judge Michael Trickey (Ret.) joined JAMS after serving more than 22 years as a judge, having most recently served as Acting Chief Judge for the Washington State Court of Appeals, Division I. Prior to his tenure with the Court of Appeals, he served on the King County Superior Court for nearly 18 years.

Beginning his legal career as a public defender and then transitioning to private practice, Judge Trickey gained extensive trial and appellate experience. He handled criminal defense cases and civil litigation, including family law and personal injury matters. He did substantial juvenile court work, including offender and dependency matters.

In 2018, Judge Trickey received a Recognition of Distinguished Service, Appellate Practice Section, from the King County Bar Association. He was also given a Vanguard Award in 2014 by the King County Chapter of Washington Women Lawyers.

Judge Trickey received his A.B. from the University of California, Berkeley, and he earned his J.D. from the University of Washington School of Law.

Judge Anne L. Ellington (Ret.), JAMS – Judge Anne L. Ellington (Ret.) of JAMS, served on the Washington State Court of Appeals (Division One) from May of 1995 until November of 2012, after almost 11 years on the King County Superior Court. She tried hundreds of cases and authored hundreds of opinions. She has also served as a Pro Tem Justice on the State Supreme Court.

She has been a frequent speaker on topics including trial and appellate practice, employment, tort, and contract law. She was also instrumental in improving access to justice, both as Presiding Judge of the Superior Court and as a member of the Access to Justice. Judge Ellington has a stellar reputation for being an exceptional listener and for her fairness.

Judge Ronald E. Cox (Ret.), JAMS – Judge Ronald E. Cox (Ret.) joined JAMS after more than 23 years of service on the Washington State Court of Appeals. Voters elected Judge Cox to an open position on the court in a contested election, and he took his oath of office in January 1995. During his tenure on the court, he served as Presiding Chief Judge of the entire court. He also served a separate time as Chief Judge of Division One, which is headquartered in Seattle.

While on the court of appeals, Judge Cox authored more than 1,200 decisions in a wide variety of substantive areas. Similarly, he also participated as a member of three-judge panels in decisions authored by others.

Judge Cox spent his entire legal career before joining the court at the law firm now known as K&L Gates LLP, where he was a partner. He had a commercial litigation practice, representing individuals and companies in a variety of substantive areas of law. During this time, he also served as an arbitrator under the King County Mandatory Arbitration Rules.
