SPEAKER BIOGRAPHY

Alan Wenokur, Wenokur Riordan PLLC – Alan Wenokur has been a Seattle bankruptcy attorney since 1988. He is a member of Wenokur Riordan PLLC.

Alan regularly assists individuals and businesses in bankruptcy cases and out-of-court workouts. His practice emphasizes representation of debtors in Chapter 7 and Chapter 13 bankruptcy cases, creditors in all bankruptcy proceedings, and bankruptcy litigation in all chapters. His debtor practice often involves individuals with struggling businesses and complex financial affairs.

Alan also represents Chapter 7 panel trustees in cases involving recovery of assets. These matters often feature undisclosed assets, fraudulent behavior, litigation, and/or recovery of speculative assets. He enjoys matters involving complex fact patterns, unsettled legal issues, and litigation in the Bankruptcy Courts.

Alan is a graduate of the University of Michigan Law School. He is a member of the Washington State Bar creditor/debtor section and the US Bankruptcy Court local rules committee. He is rated as AV-preeminent by Martindale Hubbell. Since 2012 he has been selected annually by his peers as a bankruptcy "SuperLawyer." He speaks regularly at professional seminars, often on the role and responsibilities of debtor's counsel in Chapter 7 cases. Alan has also volunteered his services with the King County Bar Association's Debt Clinic for over 20 years.

Vincent Nappo, Pfau Cochran – Vincent T. Nappo is a partner in the law firm of Pfau Cochran Vertetis Amala PLLC, where he devotes the bulk of his practice towards empowering and providing a voice to those who have been victims of childhood sexual abuse. He has successfully litigated claims against individual perpetrators, the Catholic Church, the Boy Scouts of America, school districts, daycare centers, the Department of Social and Health Services, and the State of Washington, among others. In recent years, Mr. Nappo has expanded his practice to represent survivors of human sex trafficking, including children sold for sex on the Backpage.com website. In addition to his work on behalf of abuse survivors, his practice includes complex injury cases involving civil rights violations, government liability, and medical malpractice. Mr. Nappo currently serves as Secretary/Treasurer of the WSBA Litigation Section Committee. He received his B.A. degree from the University of Colorado at Boulder and his J.D. degree from the University of Washington School of Law.
