SPEAKER BIOGRAPHY

Professor Andrew Siegel, Seattle University School of Law - Andrew Siegel is a professor of law at Seattle University School of Law. He researches and writes about constitutional theory, contemporary constitutional and public law, and American legal history. He is a nationally recognized expert on the United States Supreme Court, who frequently lectures on that subject in a variety of academic and professional settings. He is a co-author of “The Supreme Court Sourcebook” and his scholarship has appeared in a variety of influential journals including the Texas, Fordham, and UC-Davis Law Reviews, the Harvard Civil Right-Civil Liberties Law Review, and the University of Pennsylvania Journal of Constitutional Law. He is also a frequent commentator on the Supreme Court and constitutional law for local and national television, radio, and newspapers.

Professor Siegel joined the law school in 2007 after five years teaching at the University of South Carolina School of Law. Before entering the legal academy, Professor Siegel served as a law clerk to Judge Pierre N. Leval of the United States Court of Appeals for the Second Circuit and to Justice John Paul Stevens of the United States Supreme Court and practiced as a litigation associate in the New York office of Wilmer, Cutler & Pickering. Professor Siegel graduated summa cum laude from Yale College, has a master's degree in history from Princeton University, and graduated summa cum laude and first in

his class from New York University School of Law, where he was also an Executive Editor of the New York University Law Review.

Professor Siegel has held a variety of leadership positions in his time at Seattle University. From 2014 to 2017, he served as Associate Dean for Planning and Strategic Initiatives, where he led efforts to develop and launch a variety of creative degrees, programs, and courses. He has also chaired the Strategic Planning, Budget, Faculty Appointments, Personnel Review, Curriculum, Executive, and Dean's Advisory Committees. He is an innovative teacher of a wide variety of courses involving Constitutional Law, Torts, American Legal History, Civil Procedure, and the United States Supreme Court.
