SPEAKER BIOGRAPHY

Dominique Davis, Community Passageways – Dominique Davis is Founder and CEO of Community Passageways, where he works to improve racial parity in schools, prisons and communities. He sits on the King County Juvenile Justice Equity Steering Committee where he works with King County Superior Court judges to address racial inequity in the juvenile justice system, Our Best Advisory Council to advise the Mayor and City leaders on a long-term strategy to support young black male achievement, the Immigrant Family Institute Community Advisory Committee, and the Mayor's Youth Opportunity Initiative Justice Advisory Committee. He has previously served as Co-Director of the 180 Program, which was named 2015 Best New Nonprofit by Seattle Foundation and Seattle Met Magazine under his leadership. Dominique received the NW Justice Forum's 2017 Restorative Justice Award and was recently named one of the Most Influential Seattleites of 2017 by Seattle Magazine. He also enjoys being a coach and personal trainer in the community.

Polly Davis, King County Office of Alternative Dispute Resolution – Polly is a mediator, negotiator, and trainer. During her more than 20 years as a mediator, she has worked with the Northwest Institute for Restorative Justice; the King, Snohomish and Pierce County Dispute Resolution Centers; Conflict Resolution, Research and Resource Institute (CRI); and the King County Alternative Dispute Resolution Office.

Polly is a specialist in the prevention, management, and resolution of conflict with more than 15 years of experience working with community, non-governmental organizations, environmental, and governmental sectors addressing areas including matters of human rights. She is also a developer and trainer of culturally pertinent and topically applicable training curricula and coach.

Sean Goode, Choose 180 – Sean is a cause driven leader who works through the non-profit CHOOSE 180 to decriminalize youthful behavior by creating alternatives to the criminal legal system. Prior to serving the community in this capacity he served as a chaplain at Juvenile Detention, championed gang intervention efforts, created employment opportunities for youth in at-risk communities and worked in educational advocacy to implement programming that supported young people's readiness for Kindergarten, High School and College.

Sean is considered a national expert on justice reform and is frequently sharing the work of CHOOSE 180 and the transformative power of restorative practices throughout the country. He has been appointed by the governor to the Washington State Partnership Council on Juvenile Justice where he serves as the vice-chair addressing statewide issues of the criminalization of adolescent behavior.

Jaime Hawk, ACLU of Washington – Jaime Hawk is working to reform the state’s criminal justice system. Before this position, she was Of Counsel with Terrell Marshall Daudt & Willie in Seattle working on civil rights litigation. She was previously a federal and state public defender, and a law clerk for a federal judge. She began her legal career as an attorney fellow on the U.S. Senate Judiciary Committee staff of Edward M. Kennedy in Washington, D.C. Ms. Hawk has taught as an adjunct law professor at Gonzaga University, where she attended law school as a Thomas More Scholar. She is a member of the ABA House of Delegates and serves in other access-to-justice leadership efforts, including as a member of the Washington Task Force on Unaccompanied Children. Ms. Hawk is also committed to issues of international human rights, having served on the board of directors for the Center for Women and Democracy and joining in several of its international delegations. Jaime also serves in leadership on the Removing Barriers sub-committee of the KCBA’s Public Policy Committee.

Katie Hurley, King County Department of Public Defense – Katie graduated from law school in 2006 and has spent the majority of her time since then representing youth charged with crimes in King County Juvenile Court.

Marcus Stubblefield, King County Office of Performance, Strategy and Budget – Marcus oversees King County’s efforts to transform the entire criminal justice system through strategic partnerships, policy and practice reform yielding better outcomes for everyone the criminal justice system touches. For the last 10 years he served as the program manager/systems integration coordinator. Marcus’ educational background includes degrees in Sociology and Business Management plus 20 years’ experience working with and advocating for underserved communities, predominantly youth and families. Marcus was previously employed as Program Manager, Counselor and Case Manager for SafeFutures Youth Center (SFYC) a non-profit serving juvenile justice, gang-involved youth and young adults in Southwest Seattle. He also worked with youth and communities as an employee of the City of Seattle Parks and Recreation Department.
