



## How could Taliban take over Afghanistan?

- Afghanistan was neglected:

    - Rumsfeld (Secretary of Defense): "I had been told he [President Bush] wanted to meet with Gen. McNeill."
    - Bush: "Who is General McNeill?"
    - Rumsfeld: "he is the general in charge of Afghanistan."
    - Bush: "Well, I don't need to meet with him."
  - 2005:
    - Neumann (US Ambassador to

  - PM of Pak. Khan: "We had created these Jihadi groups in the 80s. We had indoctrinated them in the idea of Jihad that foreign occupation in Afghanistan, it was religious duty to fight them."

    - Gen. Hamid Gul (former head of Pakistan ISI):

## Current Situation in Afghanistan

- US has frozen Afghanistan reserves
- WB & IMF have suspended funds to Afghanistan
- UN: 18 million Afghans facing humanitarian disaster
- UNDP: Drought, Covid-19, & War raising poverty rate to 97%
- Govt. agencies are shut down
- Banks are shut down
- Food prices have skyrocketed
- Healthcare and medicine not available
- Borders are closed
- Resistance of Northern Alliance continues
- ISIS-K competes with Taliban

- Taliban govt not inclusive (includes ONLY Taliban)
  - Members of Taliban govt are sanctioned by US & UN
- Protest/demonstration is criminalized.
- Women are prohibited from going into community without a male guardian.
- Ministry of Women Affairs is dissolved.
- Women are prohibited from going to work
- Schools are gender segregated; curricula is focusing on Islam; science is removed (against Islam)
- Taliban still have close ties with Al Qaeda and ISIS-K
- Taliban minister of higher education: higher education is not valued because
  - Uneducated Taliban are better than Masters and PhDs
- Taliban are going bouse to bouse and arresting

## Taliban's Law?

- 2001 August 15, 2021
  - Sources of law:
    - (1) Statutes (2) Sharia (3) Customs/traditions
  - Constitution
  - Hundreds of Statutes regulating various aspects of life:
    - Administrative, commercial, civil, criminal, employment, mediation, arbitration, mining, public welfare, disability, competition, e-signature, distance learning, intellectual property, copy right, trademark, investment, etc.
  - Afghanistan joined numerous international conventions &

- 1996-2001: Taliban had no expertise in legislation. They kept some old laws like Civil Code
  - Taliban issued decrees/messages (based on extreme interpretation of Islam) that
    - forced religious prayers, prohibited gambling and smoking, restricted women rights, restricted access to information, banned expensive weddings, forced beards and clothing regulations, regulated land affairs, and court procedure
- August 15 Present
  - Taliban: "In the Islamic Emirate, all
     court proceedings are in according to

## with Taliban?

- Yes: To alleviate humanitarian catastrophe
  - To provide food and medicine to people who are in immediate need
  - To open airports and borders to





## engage:

- We remain enemies as of 10am September 6, 2021, we lost 2,352 US Service Members in Operation Enduring Freedom
- Ties to Al Qaeda, who were responsible for 911
- Reduces the risk of them overtaking surrounding nations and expanding, including nations with nuclear weapons
- They have violated every "agreement" & norm on offer there is no evidence which suggests cooperation will succeed
- No real negotiations ever occurred they always knew we were leaving
- They do not need us, and I dare say they do not want us; Will not accept conditional support
- Association with Taliban may harm the United States relationships with the international community
- · Assistance may not benefit Afghans
- Whether you consider the right thing to do as a moral



## to engage...



- Each transaction is different but must be considered carefully.
- Limited Engagement:
  - To keep the borders open for the refugees to exit Afghanistan
  - To provide immediate humanitarian assistance: food, medicine, and safe refugee camps.
- Conditional Engagement:
  - Prior to recognizing Taliban gov. and providing financial assistance, Taliban should:
    - Cut ties with Al-Qaeda and ISIS.
    - Form an inclusive government in which women and leaders of diverse Afghan ethnicities have a proportionate role.
    - Respect human rights
    - All commitments should be created such that they may be abandoned immediately if the Taliban resumes cooperation with terrorist organizations
- Sanction Pakistan for sponsoring terrorism and invading

## **OFAC & International Sanctions**

- Office of Foreign Asset Control List this information is likely to change rapidly, so refer to primary sources often.
- As of now, there is not a general license as there are with many other nations subject to sanctions, such as Cuba, Venezuela, Libya, etc.
- There is not an "anti-Afghanistan" program of sanctions – however, there is an "anti-Taliban" program
- Expect this to change (probably more than once) with executive orders in the coming weeks.

- International Sanctions against Taliban
- The UN Security Council can take action to maintain or restore international peace and security under Chapter VII of the United Nations Charter. Sanctions measures, under Article 41, encompass a broad range of enforcement options that do not involve the use of armed force. Since 1966, the Security Council has established 30 sanctions regimes, in ... as well as against ISIL (Da'esh) and Al-Qaida and the Taliban.
- Note: the territorial limits of sanctions

## corruption

The Foreign Corrupt Practices Act of 1977, as amended, 15 U.S.C. §§ 78dd-1, et seq. ("FCPA"), was enacted for the purpose of making it unlawful for certain classes of persons and entities to make payments to foreign government officials to assist in obtaining or retaining business.

- Position buying Awarding opportunities in the police force, judiciary or civil service based on bribes as opposed to merit
- Nepotism/clientelism Awarding positions based on personal relationship/kinship networks rather than merit
- Offering and asking for preferential treatment – This includes giving bribes to expedite the processing of business documents or access to government-owned land



## practices act best practices

- When a business expands into any new markets looking for new growth opportunities, they must be careful. Particularly, multinational companies face the risk that one of their subsidiaries, affiliates, employees, or agents may engage in misconduct in violation of the U.S. Foreign Corrupt Practices Act (FCPA).

- Caution: DO NOT USE LEAKED CLASSIFIED INFORMATION IN
- Chelsea Manning unlawfully provided us with most info applicants

#### MEMORANDUM FOR DOD SECURITY DIRECTORS

SUBJECT: Notice to DoD Employees and Contractors on Protecting Classified Information and the Integrity of Unclassified Government Information Technology Systems

Classified information, whether or not already posted on public websites, disclosed to the media, or otherwise in the public domain remains classified and must be treated as such until it is declassified by an appropriate U.S. government authority. It is the responsibility of every DoD employee and contractor to protect classified information and to follow established procedures for accessing classified information only through authorized means. Leadership must establish a vigilant command climate that underscores the critical importance of safeguarding classified material against compromise.

Accordingly, we request all DoD components send prompt notification to your employees and contractors reminding them of these obligations. Procedures for responding to classified information found in the public domain are attached. These procedures will be promulgated in future DoD issuances. - Establishing an "Ongoing Security Threat" should <u>not</u> be taken for granted you will want to establish more of a summary judgment standard of when the Taliban came and threatened you, who/what/when/where/how and why you have a serious credible threat against your life not just stating that "you are afraid" we're all afraid, tell me "what color was the gun they put to your head?"
- Cannot apply for SIV if you have applied for asylum
- There are resettlement benefits that should be applied for if this visa is granted
- DO NOT LIE OR EXAGGERATE ANY CLAIMS the Afghans working with the US have more information recorded about them than the average US citizen as it is, including bioinformatics. If you have worked with the US before, you have certainly submitted this type of information before, and your previous answers will be tested against new answers. If someone in your family has ties to heroin smuggling, it is likely the US military knows this information. Make sure
